

Minutes of the Argos Old Gold Booster Club
Monthly Meeting
Held on June 11, 2018

Mandy requested we consider offering this. After discussion, Patti Van Der Weele made a motion to try this during the sale that will be held in June at the Summer Kick-Off Festival. Melanie Dean seconded the motion and the motion passed 5-0. Old Gold will need more volunteers to help during the sale at the festival. Mandy will create a sign up sheet which will be emailed to members. Also under Old Business, Patti Van Der Weele has received a request for student pictures to use, from the printers, of the activities calendar. This request has been discussed with Superintendent Ned Speicher and because parental consent is given to the school to use student pictures for various publications and not given to Old Gold, we will not be using pictures but will ask the printer to add some additional advertising for Old Gold. Melanie Dean asked that Patti Van Der Weele contact Abby Ennis, school nurse, about the details to order the first aid bags discussed at the May meeting.

Under New Business: Melanie Dean reported the Treasurer annual audit will need to be done at some point between the July and August meetings by two members of the club. Laura Smith and Patti Van Der Weele volunteered to conduct the audit. Due to low attendance at

monthly meetings, the officer nominations for 2018-2019 will need to remain as the officers are now with Melanie Dean and Laura Smith as co-Presidents, Andy Nifong as Treasurer, Mandy Nifong as Spirit Wear Coordinator and Patti Van Der Weele as Secretary.

The July meeting will be held on Tuesday, July 10th at 6:30 p.m. at Bourbon Street Pizza.

Patti Van Der Weele made a motion to adjourn and Mandy Nifong seconded the motion. The motion passed.
